- 1. Discussion and possible action regarding the monthly operations report from Bob Hanus of Western Environmental Technologies regarding the operation and maintenance of the water and sewer facilities and status of projects.

Bob said the green liquid that was discharged illegally into the wastewater system did upset the chemical balance in the plant. Jennifer was asked to create a letter for the property owners with suggestions on what can be placed in the sewer system and what penalties could or will occur for future illegal discharge events. Jennifer was also asked to write a letter for Tiffany to hand to builders on the rules and requirements of the District and one to be sent with a meter request or transfer of ownership.
